PHYSICIAN COURSE DESCRIPTION

This program has been developed from physician forums, member evaluations and comments in an effort to provide the latest information to KAEPS members on new diagnostic and surgical procedures in ophthalmology. This meeting of lectures and question and answer sessions will provide information concerning updates in ophthalmic treatments and surgery. - 3. Discuss new treatments and medications for cataract complications
- 4. Discuss new treatment modalities for retina patients
- 5. Discuss the impact of legislation, both federal and state, on quality patient care in Kentucky
- 6. Discuss new treatment modalities for neuro-ophthalmology
- 7. Understand the fraud and abuse implications related to E/M Coding and Documentation
- 8. Understand the need to perform self-audits of coding and documentation.
